C. ATHLETE ELIGIBILITY

C.1. Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of

Competitions, including the rules and conditions of participation established by the EOC and WDSF, may participate in the 2023 European Games.

C.2. Age requirements

To be eligible to participate in the 2023 European Games, athletes must be born on or before 31 December 2008.

C.3. Additional WDSF requirements

Athletes must also comply with the following criteria:

- Adhere to the WDSF Rules and Regulations Manual (Breaking) outlined here
- Must be part of the WDSF Athletes and Competition License system
- Must have a passport / citizenship of the country (NOC) they represent during the entire qualification period of Paris 2024 Olympic Games and during the Games, therefore from 1 July 2022 until 11 August 2024

D. QUALIFICATION PATHWAY

The qualification system allows the participation of the best athletes through a fair and transparent process within the framework of the Olympic Charter.

D.1. Qualification Places

Quota places allocation priority:

D.2. Host NOC Places

If the host NOC does not qualify any athlete in the respective gender, one (1) quota place per gender is assigned to the host NOC presupposed the nominated athlete has a valid and subsisting WDSF ID card, Athletes License and is registered in the WDSF BfG World Ranking List at the time of nomination and at the time of European Games.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

For 2022 WDSF European Breaking Championships

On 11 November 2022, in agreement with the WDSF the EOC will inform NOCs, in writing, of the quota places they have obtained at the Qualification Event.

By 20 November 2022, eligible NOCs must inform the EOC, in writing, whether or not they intend to use the allocated quota places and participate in the 2023 European Games.

For 2023 (Date and Place TBC) WDSF European Breaking Championships

Within five days after the event and in agreement with the WDSF, the EOC will inform NOCs, in writing, of the quota places they have obtained at the Qualification Event.

Two weeks after the event, eligible NOCs must inform the EOC, in writing, whether or not they intend to use the allocated quota places and participate in the 2023 European Games.

Ranking List Quota Places

On 1 May 2023, Closing date for quota allocation through the WDSF BfG World Ranking List.

On 6 May 2023, in agreement with the WDSF the EOC will inform NOCs in writing, of the quota places they have obtained through the Ranking List.

By 15 May 2023, eligible NOCs must inform the EOC, in writing, whether or not they intend to use the allocated quota places and participate in the 2023 European Games.

By 20 May 2023, all available quota places will be reallocated.

F. REALLOCATION OF UNUSED QUOTA PLACES

All unused quota places, including the host NOC places, will be reallocated to the next eligible athlete in the WDSF BfG Ranking list of 1 May 2023, respecting the maximum number of athletes per NOC.

In accordance with <u>Olympic Qualification System</u> one quota place for each gender will be allocated at Krakow and Malopolska 2023 European Games for the Olympic Games in Paris 2024.
