B. QUOTA PLACES

B.1. Maximum number of athletes per NOC

Event	Quota per NOC
Men	12* (4 per event)
Women	12* (4 per event)
Total	24* (4 per event)

* In each event NOC can replace one athlete for the team event after the individual event. The replacing athlete must be entered as Alternate Athlete (Ap). This athlete will not be allocated bed in the AVL and will not be eligible for team support grant.

C. ATHLETE ELIGIBILITY

C.1. Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).



Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions, including the conditions of participation established by the EOC and the ECF, may participate in the 2023 European Games.

C.2. Age requirements

All athletes participating in the 2023 European Games in fencing must be born before 24 June 2010.

C.3. Additional ECF requirements

All actively participating fencers, referees, and coaches must be in possession of the FIE license for the season 2022-2023.

D. CONFIRMATION PROCESS FOR QUOTA PLACES

The EOC will send the Quota Place Confirmation form by email to all eligible NOCs by 15 April 2023.

By 30 April 2023, eligible NOCs must inform, by email, the EOC on the number of quota places they intend to use at the 2023 European Games.

E. QUALIFICATION TIMELINE

F. OLYMPIC GAMES PARIS 2024 QUALIFICATION

Ranking points from European Games are counted towards the FIE official senior rankings (individual and team) for Paris 2024 Olympic Games qualification.
